1. Review Action Items from the last meeting.

Comments were submitted by the OIPC to the invasive species act EBR.

Comments: In the situations where an EBR is posted, it may not be ideal for our governmental representatives to provide comments, but all have agreed that they are more than happy to provide clarification and provide advice to our submissions. However helping the OIPC to develop their position on an EBR that is posted by the government would seem like a conflict of interest.

An updated version of the OIPC Constitution and Bylaws was posted to the discussion forum on the OIPC website. If everyone could log on and go through these items, the document can be updated again. The program is quite easy to use.

JOINT AGM with SERO

We were approached by SERO (Ontario Society of Ecological Restoration) to host a joint meeting. The meeting would be mid-september in the Peterborough/Kingston area.

Seems like a good fit as Invasive plant control and restoration go hand in hand.

All Board members seemed pleased with this idea.

ACTION: Rachel to work with SERO and work out more details for this joint meeting.

The draft Canada-Ontario Agreement on Great Lakes Water Quality and Ecosystem Health (COA) is available for the public on the EBR, closing date for comments is July 3rd. The OIPC will need to get comments in by the end of June. OIPC may be most interested in Annex 6 which speaks to aquatic invasive species.
