### 1. Review Items From Previous Meeting

ACTION: **All board members** to send our comments on the MNR Discussion Paper (final draft) around to their organizations.

ACTION: Hayley to attach final discussion paper comments to the minutes from this meeting

Board members submitted comments on the MNR Discussion Paper, and OIPC submitted a response to the MNR through the Environmental Registry.

ACTION: Hayley to ensure that the sound bites are discussed at the Communications Committee meeting

The sound bites, or Q&As were discussed at the Communications meeting. These will be a resource for staff, board and volunteers to refer to for media interviews, presentations etc.... Danielle drafted the content and the Communications committee members provided feedback.

ACTION: Danielle to send the updated Q&As to the Board (attached).

ACTION: **ALL BOARD MEMBERS!** We need ideas for ISC project proposals for 2014/15 by OCTOBER 4<sup>th</sup>!!

Board members provided suggestions and OIPC submitted 8 preliminary proposals for funding to the ISC (totally over \$200,000).

2. **Introduction to new board member Jeanine West.** Jeanine is our new board member representing Landscape Ontario.

### 3. Staff Updates

#### Hayley's Staff Update:

Hayley has been very busy with the Invasive Species Centre funding proposals, planning the AGM, and submitting the final report to the Ontario Community Environment Fund (OCEF) for the Water Chestnut Control Project taking place in Voyageur Provincial Park.

### Danielle's Staff Update:

Danielle attended the Ontario Vegetation Management Association's AGM along with Joe Halloran to present on the Clean Equipment Protocol.

She met with the Ontario Phragmites Working Group, in their first meeting as an official OIPC committee, and set them up with members' access to the OIPC website and Forum.

Ongoing projects include: Look Before You Leave expansion, Best Management Practices, training modules, website and social media (note: there is now an online donation button accessible from each page of the OIPC website).

#### 4. New Secretary/Treasurer

Dawn is no longer able to serve as the Secretary/Treasurer. The board needs to elect a new one as soon as possible. Government staff are unable to sit on the Executive, and OFAH staff are no longer to act as Treasurer. According to the by-laws this does not \*have\* to be a dual position.

The other 2 Executive positions are also open for nominations. Both Owen and Ken have served their terms as President and Vice-President. Their terms end December 2013.

Action: Hayley to send out a call for nominations for Treasurer/Secretary, President and Vice-President to Board members.

Action: Hayley to check on the dates that other Board members' terms are up.

Action: Hayley to add to November's agenda a discussion of election and terms of service.

Action: Hayley to include a paragraph in the By-laws that clarifies how the Executive is put into place.

### 5. Constitution and By-laws

The OIPC Constitution was sent to lawyer Ian Attridge, and he has provided comments on the document (attached).

Action: All Board members are to review and provide feedback by **Friday November 15<sup>th</sup>**, **2013**. The next meeting will be dedicated to discussing the constitution.

#### 6. Other Items

There was a discussion on how to engage new Board members and encourage involvement by Board members who have not been active or attending meetings to ensure that their sector is represented.

Action: Ken will contact members who have not been active for a long period to determine if they wish to occasionally designate the task to another person, or step down and recommend a replacement, or have OIPC find one.
