## 1. Review action items from the last meeting.

ACTION: **Dave** to provide Owen with Cam and Tracy's contact information and Owen to contact. Owen spoke to Cam no definitive response at this time. Tracy has not been contacted yet.

ACTION: If anyone has any other suggestions for potential executive committee members, please contact Owen. Owen Spoke to Carla Grant, but she is unable to commit the time needed for the position.

# 2. Executive committee update

Rachel spoke with Kelly Withers, who has expressed some interest in the President position, to find out if the ISC had considered the possibility that her being President could be perceived as a conflict of interest. ISC did speak about this and two thoughts were brought up;

- The agreement ISC has with MNR. They would have to disclose the information and it would need to be ruled on by the Deputy Minister. All would need to be cleared prior to her becoming President.
- When OIPC submits a proposals for funding to the ISC, Kelly does not make decisions on the projects that are funded so this would not be a problem.

The ISC are meeting today, ACTION: Rachel will get details about their discussion.

It is important that the Board discuss the candidates further in a face to face meeting in the next month. The next Board meeting will be dedicated to filling the executive committee and moving forward. This may be best done in a face to face meeting.

## 5. Staff updates

#### Kellie:

- Held 2 landowner workshops in partnership with the invading Species Awareness Program, York Region, and Lake Simcoe. One was in Aurora at Shepherds Bush and the other was on Georgina Island for the First Nation Community and the cottagers.
- Finishing the aquatic invasive plant bmp. It will be going for editing today and will be desktop publish very soon.
- Entering the content for the Ontario *Phragmites* Working Group website, it should be up and running in the next couple weeks. ACTION: **Kellie** to send Owen the link.
- Forgot to mention: Held an invasive plant event through BEAN. The "Pull, Plant and Pollinate" event was held in Peterborough. The OIPC lead a number of volunteers to pull goutweed from local garden and replant with some beautiful pollinator plants.

#### Rachel:

- Report for MNR, we sent out a survey last month to determine the scope of invasive species management plans in Ontario. The information is being analyzed and a final report is almost finished.
- ISC project. We are working with York region on a draft invasive species management strategy. Once the strategy for York is complete we will use it to create a template which other municipalities can use to create their own strategy.
- Leading the Weeds Across Borders tour committee. The event will be held on Oct 15-17 in Ottawa.
- Planning the OIPC AGM, Waiting on abstracts which are due July 16<sup>th</sup>. The event is Sept 15/16 in Peterborough Ontario.
- Spoke to a group in Pembroke on the Clean Equipment Protocol. Members of the Algonquin Forestry Authority and Ontario Parks we're in attendance. Received great feedback on the protocol, and interest in following it in the Park.
- Lead a talk and invasive plant walk for the ISAP summer students "Hit Squad".
